HUGULEY WATER, SEWER & FIRE PROTECTION TAP FEES

¾" Meter with Box, Backflow and Curb Stop

(For connections on same side as water main or across standard 2 lane highway)

\$1,200.00

1" Meter With Box, Backflow and Curb Stop

(For connections on same side as water main or across standard 2 lane highway)

\$1,400.00

- All taps Over 1" will be priced per Job.
- All taps which require a service line under a highway with more than standard 2 lanes will be priced per job regardless of size.
- **Any tap fee which is paid to the Authority and the tap is not installed for any reason within 18 months of the date the tap fee is paid, and then the fee paid will AUTOMATICALLY be refunded.**

FIRST 3,000 GALLONS PER MONTH OR LESS	\$26.82 MINIMUM USAGE CHARGE
NEXT 3,000 GALLONS	\$8.84 PER 1,000 GALLONS
NEXT 6,000 GALLONS	\$8.09 PER 1,000 GALLONS
OVER 12,000 GALLONS	\$6.98 PER 1,000 GALLONS

NOTES:

STANDARD RATE SCHEDULE APPLIES TO ALL CUSTOMERS WHICH HAVE A METER LESS THAN 2 INCHES ANY CUSTOMER WHICH HAVE A 2" OR LARGER METER SHALL BE CHARGED AT A COMMERCIAL RATE OR AN INDUSTRIAL RATE IF AVERAGE USAGE REQUIREMENT IS MET.

4" METER	\$192.71	FIRST 25,000 GALLONS MINIMUM CHARGE
	\$6.98	ALL OVER 25,000 PER 1,000 GALLONS
6" METER	\$297.44	FIRST 40,000 GALLONS MINIMUM CHARGE
	\$6.98	ALL OVER 40,000 PER 1,000 GALLONS
8" METER	\$367.26	FIRST 50,000 GALLONS MINIMUM CHARGE
	\$6.98	ALL OVER 50,000 PER 1,000 GALLONS
10" METER	\$437.07	FIRST 60,000 GALLONS MINIMUM CHARGE

NOTES:

ALL CUSTOMERS WHICH HAVE 2" METER OR LARGER SHALL BE CHARGED AT A COMMERCIAL RATE. EXCEPTION WILL BE FOR ANY INDUSTRY THAT QUALIFIES FOR AN INDUSTRIAL RATE BASED ON USAGE.

Industrial Water Service Fees

INDUSTRIAL WATER RATE SCHEDULE

EFFECTIVE - OCTOBER 1, 2024

FIRST 100,000 GALLONS PER MONTH OR LESS	\$698.30 (MINIMUM USAGE CHARGE)
OVER 100,000 GALLONS	\$5.18 PER 1,000 GALLONS

NOTES:

TO QUALIFY FOR AN INDUSTRIAL RATE:

- THE CUSTOMER MUST USE 1,000,000 GALLONS OR MORE PER MONTH AS A MONTHLY AVERAGE. (12 Month Rolling Average)
- IF USAGE FALLS BELOW 1,000,000 GALLON AVERAGE THEN CUSTOMER WILL BE CHARGED AT COMMERCIAL RATE BASED ON SIZE OF METER.
- THE CUSTOMER MUST BE AN INDUSTRY.

ALL RATES ARE SUBJECT TO CHANGE.
